**LEGAL DESCRIPTION OF A 7.052 ACRE PARCEL

Being a parcel of land situated in part of the Southeast Quarter of Section 6, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the Southeast Corner of said Section 6;

thence on an assumed bearing of N 00° 05' 29" E along the centerline of Township Highway 96 a distance of 918.96 feet to a set MAG nail and being the **POINT OF BEGINNING**, passing a set MAG nail a distance of 657.54 feet;

thence N 88° 42' 17" W a distance of 500.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 00° 05' 29" W a distance of 261.42 feet to a set iron rod on the north line of a parcel of land currently owned by Marcus Thiel, et ux;

thence N 88° 42' 17" W along the north line of said Thiel parcel a distance of 166.10 feet to a set iron rod on an east line of a parcel of land currently owned by Donald E. Frisch, et al, Trust, marking the northwest corner of said Thiel parcel;

thence N 00° 07' 56" E along an east line of said Frisch parcel a distance of 657.91 feet to a set iron rod on a south line of said Frisch parcel;

thence S 88° 40' 21" E along a south line of said Frisch parcel a distance of 665.64 feet to a set MAG nail on the centerline of Township Highway 96 marking a southeast corner of said Frisch parcel, passing a set iron rod on a distance of 645.54 feet;

thence S 00° 05' 29" W along said centerline a distance of 396.13 feet to the **POINT OF BEGINNING**.

Containing in all 7.052 acres of land, more or less, of which 0.273 acre, more or less, will be contained within the right-of-way of Township Highway 96. The above described property being subject to all legal highways and easements of record.

FOR STANLEY FREY**

Being a parcel of land situated in part of the Southeast Quarter of Section 6, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the Southeast Corner of said Section 6;

thence on an assumed bearing of N 00° 05' 29" E along the centerline of Township Highway 96 a distance of 657.54 feet to a set MAG nail marking the northeast corner of a parcel of land currently owned by Marcus E. Thiel, et ux and being the **POINT OF BEGINNING**;

thence N 88° 42' 17" W along the north line of said Thiel parcel a distance of 500.00 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 00° 05' 29" E a distance of 261.42 feet to a set iron rod;

thence S 88° 42' 17" E a distance of 500.00 feet to a set MAG nail on the centerline of Township Highway 96, passing a set iron rod a distance of 480.00 feet;

thence S 00° 05' 29" W along said centerline a distance of 261.42 feet to the **POINT OF BEGINNING**.

Containing in all 3.000 acres of land, more or less, of which 0.180 acre, more or less, will be contained within the right-of-way of Township Highway 96. The above described property being subject to all legal highways and easements of record.
