Commencing at a found stone in a monument box marking the northwest corner of said Section 26;

thence on an assumed bearing of N 89° 51' 00" E along the centerline of Township Highway 28 a distance of 1990.50 feet to a set MAG nail and being the **POINT OF BEGINNING**;

thence continuing N 89° 51' 00" E along said centerline a distance of 40.00 feet to a set MAG nail;

thence S 00° 04' 45" W a distance of 270.00 feet to a set iron rod, passing a set iron rod a distance of 25.00 feet;

thence N 89° 51' 00" E a distance of 312.42 feet to a set iron rod on the west line of a parcel of land currently owned by Daniel M. Dible;

thence S 00° 04' 45" W along the west line of said Dible parcel a distance of 1672.76 feet to a set iron rod;

thence S 89° 51' 00" W a distance of 68.85 feet to a set iron rod;

thence N 46° 21' 52" W a distance of 326.79 feet to a set iron rod;

thence N 00° 04' 45" E a distance of 169.38 feet to a set iron rod;

thence N 83° 51' 34" E a distance of 267.25 feet to a set iron rod;

thence N 00° 04' 45" E a distance of 1209.36 feet to a set iron rod;

thence S 89° 51' 00" W a distance of 312.42 feet to a set iron rod;

thence N 00° 04' 45" E a distance of 310.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 285.00 feet

thence continuing N 89° 51' 00" E along said centerline a distance of 312.42 feet to a
found MAG nail marking the northwest corner of a parcel of land currently owned by
Daniel M. Dible, et ux;

thence S 00° 04' 45" W along the west line of said Dible parcel a distance of 270.00 feet
to a set iron rod, passing a found iron rod a distance of 25.00 feet;

thence S 89° 51' 00" W a distance of 312.42 feet to a set iron rod;
