thence S 62° 52' 18" E one hundred ninety-six and sixty hundredths (196.60) feet along the centerline of said ditch and the north line of said Lewis' 1.45 acre parcel to the northeast corner thereof, referenced by a set iron rod S 00° 00' 00" W at 63.97 feet;

thence S 00° 00' 00" W sixty-three and ninety-seven hundredths (63.97) feet said Lewis' east line to a set iron rod;

thence N 58° 09' 21" W two hundred five and ninety-eight hundredths (205.98) feet to a set nail marking the centerline of Township Highway 136, the west section line and said 1.45 acre Lewis parcel's westerly line, passing a set iron rod for reference marking the east right of way thereof;

thence N 00° 00' 00" E forty-four and ninety-four hundredths (44.94) feet along said centerline, section line and property line to **THE POINT OF BEGINNING**.



thence N 58° 09' 21" W two hundred five and ninety-eight hundredths (205.98) feet to a set nail marking the centerline of Township Highway 136, the west section line and said 1.45 acre Lewis parcel's westerly line, passing a set iron rod for reference marking the east right of way thereof;

thence N 00° 00' 00" E forty-four and ninety-four hundredths (44.94) feet along said centerline, section line and property line to **THE POINT OF BEGINNING**.
