SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, VILLAGE OF NEVADA, BEING THE EAST PART OF LOT 8 OF GREGG'S ADDITION AS SHOWN AND DELINATED IN PLAT BOOK 2, PAGE 61, AS CONVEYED TO JULIA JUSTICE OF RECORD IN OFFICIAL RECORD 4, PAGE 340 AND MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT THE SOUTHEAST CORNER OF LOT 8 IN SAID GREGG'S ADDITION AT AN IRON PIN SET IN THE WEST RIGHT-OF-WAY OF MORRISON STREET (60' IN WIDTH) AND BEING THE TRUE POINT OF BEGINNING;

THENCE NORTH $89^{\circ}32'13''$ WEST, A DISTANCE OF 160.00 FEET WITH THE SOUTH LINE OF SAID LOT 8, AND THE NORTH LINE OF LOT 9 AS CONVEYED TO JUDITH A KELLOG OF RECORD IN DEED BOOK 205, PAGE 476 TO AN IRON PIN SET AT THE NORTHWEST CORNER OF SAID KELLOG TRACT;

THENCE NORTH $00^{\circ}10'41''$ EAST, A DISTANCE OF 64.00 FEET ALONG THE EAST LINE OF A TRACT CONVEYED TO JEFFERY A WAGGY, ETAL OF RECORD IN DEED BOOK 209, PAGE 879 TO AN IRON PIN SET;

THENCE SOUTH $89^{\circ}32'13''$ EAST, A DISTANCE OF 160.00 FEET OVER AND ACROSS SAID LOT 8, AND SAID JUSTICE TRACT TO AN IRON PIN SET IN THE WEST RIGHT-OF-WAY OF SAID MORRISON STREET;

BEGINNING FOR REFFERENCE AT THE SOUTHEAST CORNER OF LOT 8 IN SAID GREGG'S ADDITION AT AN IRON PIN SET IN THE WEST RIGHT-OF-WAY OF MORRISON STREET (60' IN WIDTH);

THENCE NORTH $00^{\circ}10'41''$ EAST, A DISTANCE OF 64.00 FEET ALONG THE EAST LINE OF SAID WAGGY TRACT TO AN IRON PIN SET;

THENCE SOUTH $89^{\circ}32'13''$ EAST, A DISTANCE OF 160.00 FEET ALONG THE CENTERLINE OF A VACATED PLEASANT LANE (16' RIGHT-OF-WAY) TO AN IRON PIN SET IN THE WEST RIGHT-OF-WAY OF SAID MORRISON STREET;
