Being a parcel of land situated in part of the Southeast Quarter of Section 25, T-1-S,
R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found P-K nail marking the intersection of the centerlines of County
Highway 107 and County Highway 29, said nail being referenced by a found iron rod
situated N 33° 26' 46" W a distance of 36.29 feet;

thence on an assumed bearing of N 89° 12' 38" W along the centerline of County
Highway 29 a distance of 733.00 feet to a found MAG nail marking the southwest corner
of a parcel of land currently owned by Jeanette A. Hewett and being the **POINT OF
BEGINNING**, referenced by a found iron rod situated N 00° 47' 22" E a distance of
20.00 feet;

thence continuing N 89° 12' 38" W along said centerline a distance of 303.26 feet to a set
MAG nail;

thence N 00° 05' 35" E a distance of 388.53 feet to a set iron rod on a southerly line of a
parcel of land currently owned by Joseph Yost, et ux, passing a set iron rod a distance
30.00 feet;

thence S 89° 12' 38" E along a southerly line of said Yost parcel a distance of 307.97 feet
to a found iron rod marking the northwest corner of said Hewett parcel;

thence S 00° 47' 22" W along the west line of said Hewett parcel a distance of 388.50
feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 358.50 feet and
a found iron rod a distance of 368.50 feet.

Containing in all 2.726 acres of land, more or less, of which 0.209 acre, more or less, will
be contained within the right-of-way of County Highway 29. The above described
property being subject to all legal highways and easements of record.

1036.26 feet to a set MAG and being the **POINT OF BEGINNING**, referenced by a set
iron rod situated N 00° 05' 35" E a distance of 30.00 feet;

thence continuing N 89° 12' 38" W along said centerline a distance of 272.00 feet to a
found MAG nail marking a corner of a parcel of land currently owned by James Jury,
et ux;

thence N 00° 05' 35" E along a line of said Jury parcel a distance of 388.53 feet to a
found iron rod marking a corner of a parcel of land currently owned by Joseph Yost,
et ux, passing a found iron rod a distance 20.00 feet and a set iron rod a distance 30.00
feet;

thence S 89° 12' 38" E along a southerly line of said Yost parcel a distance of 272.00 feet
to a set iron rod;
