Being a parcel of land situated in part of the Northeast Quarter of Section 3, T-3-S, R-15-E, Antrim Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the intersection of the centerlines of Township Highway 10 and County Highway 55, referenced by a found iron rod situated S 45° 00' 00" W a distance of 30.00 feet;

thence on an assumed bearing of N 90° 00' 00" W along the centerline of County Highway 55 a distance of 1304.32 feet to a set MAG nail and being the **POINT OF BEGINNING**;

thence S 00° 00' 00" W a distance of 439.72 feet to a set iron rod, passing a set iron rod a distance of 30.00 feet;

thence N 90° 00' 00" W a distance of 350.65 feet to a point marking a southeasterly corner of a parcel of land currently owned by Carmen D. Snyder;

thence N 00° 00' 00" E along an easterly line of said Snyder parcel a distance of 205.00 feet to a found iron rod marking an eassterly corner of said Snyder parcel, passing a found iron rod a distance of 6.83 feet;

thence S 90° 00' 00" E a distance of 18.36 feet to a set iron rod;

thence N 00° 00' 00" E a distance of 234.72 feet to a set MAG nail on the centerline of County Highway 55, passing a set iron rod a distance of 204.72 feet;

thence S 90° 00' 00" E along said centerline a distance of 332.29 feet to the **POINT OF BEGINNING**.

Containing in all 3.441 acres of land, more or less, of which 0.229 acre, more or less, will be contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Commencing at a found railroad spike marking the intersection of the centerlines of Township Highway 10 and County Highway 55, referenced by a found iron rod situated S 45° 00' 00" W a distance of 30.00 feet;

thence on an assumed bearing of N 90° 00' 00" W along the centerline of County Highway 55 a distance of 1636.61 feet to a set MAG nail and being the **POINT OF BEGINNING**, passing a set MAG nail a distance of 1304.32 feet;

thence S 00° 00' 00" W a distance of 234.72 feet to a set iron rod, passing a set iron rod a distance of 30.00 feet;

thence N 90° 00' 00" W a distance of 185.58 feet to a found iron rod marking an easterly corner of a parcel of land currently owned by Carmen D. Snyder, passing a found iron rod a distance of 18.36 feet;

thence N 00° 00' 00" E along an easterly line of said Snyder parcel a distance of 234.72 feet to a found MAG nail on the centerline of County Highway 55, passing a set iron rod a distance of 204.72 and a found iron rod a distance of 214.72 feet;
