thence S 89° 01' 38" E along the south line of said Woods parcel a distance of 1426.88 feet to a set iron rod on the west line of a parcel of land currently owned by Elizabeth M. Burnett, et al, Trust, marking the southeast corner of said Woods parcel;

thence S 00° 48' 59" E along the west line of said Burnett parcel a distance of 1174.80 feet to a found stone;
