SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, VILLAGE OF NEVADA, BEING ALL OF THE ALLEYS BETWEEN LOTS 12 & 13, 14 & 15, AND 16 & 17, AND PART OF THE ALLEY BETWEEN SOUTH STREET AND WOLFE STREET WEST OF SAID LOTS OF THE WILLIAM A. GOODBREAD'S ADDITION OF THE VILLAGE OF NEVADA OF RECORD IN PLAT CABINET A, SLIDE 19, BEING A 0.280 ACRE TRACT, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF SAID LOT 11 AND THE NORTH RIGHT-OF-WAY LINE OF SOUTH STREET (40 FEET IN WIDTH), SAID IRON PIN ALSO BEING ON THE EAST RIGHT-OF-WAY LINE OF A 16-FOOT ALLEY;

THENCE NORTH 04°01'42" EAST, A DISTANCE OF 129.56 FEET WITH THE WEST LINE OF LOTS 11 & 12 OF SAID WILLIAM A. GOODBREAD'S ADDITION, AS CONVEYED TO THE NEVADA SCHOOL DISTRICT BOARD OF EDUCATION OF RECORD IN DEED BOOK 73, PAGE 439 TO AN IRON PIN SET AT THE NORTHWEST CORNER OF SAID LOT 12, AND ON THE SOUTH RIGHT-OF-WAY LINE OF SAID 16-FOOT ALLEY;



GOODBREAD'S ADDITION OF THE VILLAGE OF NEVADA OF RECORD IN PLAT CABINET A, SLIDE 19, BEING A 0.099 ACRE TRACT, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:
