thence on an assumed bearing of S 89° 39' 43" W along the north line of said Lot #18 (north line said Donaugh parcel) a distance of 389.51 feet to a point on the east line of a parcel of land currently owned by M. J. Robey marking the northwest corner of said Donaugh parcel, passing a set iron rod a distance of 379.51 feet;

thence N 00° 01' 49" E along the east line of said Robey parcel and a line of a parcel of land currently owned by S. E. Kauble a distance of 63.50 feet to a set iron rod marking a corner of said Kauble parcel ;
