Commencing at a found stone in a monument box marking the southwest corner of Section 34, T-3-S, R-15-E, Antrim Township;

thence on an assumed bearing of N 02° 48' 30" W along the centerline of State Route 231 a distance of 1419.81 feet to a found railroad spike on the centerline of Wyandot Street, referenced by a found iron rod situated N 51° 59' 45" E a distance of 40.53 feet;

thence S 73° 30' 00" E along said centerline passing a found MAG nail a distance of 834.10 feet a total distance of 1044.46 feet to a found MAG nail referenced by a found iron rod situated N 21° 15' 02" E a distance of 33.11 feet;

thence N 21° 15' 02" E a distance of 33.11 feet to a found iron rod on the north right-of-way line of Wyandot Street marking a southeasterly corner of a parcel of land currently owned by P. J. Kramer and being the **POINT OF BEGINNING**, passing a found iron pipe in concrete a distance of 30.47 feet;

thence continuing N 21° 15' 02" E along the east line of said Kramer parcel a distance of 151.79 feet to a found iron rod marking the northeast corner of said Kramer parcel;

thence N 73° 17' 18" W along the north line of said Kramer parcel a distance of 150.00 feet to a found iron pipe marking the southeast corner of a parcel of land currently owned by Honey Creek Provisions Company;
