Being a parcel of land situated in part of the Northwest Quarter of Section 25, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the intersection of the centerlines of State Route 67 and County Highway 35, referenced by a found iron rod situated S 14° 39' 28" E a distance of 51.81 feet;

thence on an assumed bearing of N 36° 40' 18" E along the centerline of State Route 67 a distance of 614.48 feet to a set MAG nail referenced by the next mentioned set iron rod;

thence S 89° 23' 51" W a distance of 38.05 feet to a set iron rod on the west right-of-way line of State Route 67;

thence N 37° 22' 02" E along said right-of-way line a distance of 343.61 feet to a set iron rod and being the **POINT OF BEGINNING**, passing a set iron rod a distance of 330.00 feet;

thence N 46° 10' 40" W a distance of 171.63 feet to a set iron rod on a line of a parcel of land currently owned by H. W. Walton, et al;

thence N 37° 22' 02" E along a line of said Walton parcel a distance of 197.00 feet to a set iron rod marking a corner of said Walton parcel;

thence S 42° 02' 16" E along a line of said Walton parcel a distance of 173.50 feet to a set iron rod on the west right-of-way line of State Route 67 marking a corner of said Walton parcel;

thence S 37° 22' 02" W along said right-of-way line a distance of 184.39 feet to the **POINT OF BEGINNING**.

Containing in all 0.747 acre of land, more or less, being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

Being a parcel of land situated in part of the Northwest Quarter of Section 25, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the intersection of the centerlines of State Route 67 and County Highway 35, referenced by a found iron rod situated S 14° 39' 28" E a distance of 51.81 feet;

thence on an assumed bearing of N 36° 40' 18" E along the centerline of State Route 67 a distance of 614.48 feet to a set MAG nail referenced by the next mentioned set iron rod;

thence S 89° 23' 51" W a distance of 38.05 feet to a set iron rod on the west right-of-way line of State Route 67;

thence N 37° 22' 04" E along said right-of-way line a distance of 528.00 feet to a set iron rod marking the northeasterly corner of a parcel of land currently owned by B. L. and M. J. Jarvis and being the **POINT OF BEGINNING**, passing 2 set iron rods a distance of 330.00 feet and 343.61 feet respectively;

thence N 42° 02' 16" W along the northerly line of said Jarvis parcel a distance of 173.50 feet to a set iron rod marking the northwesterly corner of said Jarvis parcel;

thence N 37° 22' 02" E a distance of 5.22 feet to a set iron rod;

thence S 42° 43' 14" E a distance of 173.13 feet to a set iron rod on the west right-of-way line of State Route 67;

thence S 37° 22' 02" W along said right-of-way line a distance of 7.32 feet to the **POINT OF BEGINNING**.
