Commencing at a found iron rod marking the southeast corner of said Section 27;

thence on an assumed bearing of S 88° 50' 06" W along the south line of said Section 27 a distance of 175.00 feet to a found iron rod marking the southwest corner of a parcel of land currently owned by David Bastel, et ux and being the **POINT OF BEGINNING**;

thence continuing S 88° 50' 06" W along the south line of said Section 27 a distance of 351.00 feet to a found iron rod;

thence N 00° 31' 08" W a distance of 386.42 feet to a found iron rod marking the southwest corner of a parcel of land currently owned by Nantucket Greene Limited Partnership;

thence N 88° 50' 06" E along the south line of said Nantucket Greene parcel a distance of 217.29 feet to a set iron rod on the right-of-way line of Nantucket Drive;

thence along the right-of-way of Nantucket Drive an arc distance of 187.5515 feet along a curve to the left having a radius of 50.0000 feet, a chord of 95.3932 feet and a chord bearing of N 88° 50' 06" E to a set iron rod on the south line of said Nantucket Greene parcel;

thence N 88° 50' 06" E along the south line of said Nantucket Greene parcel a distance of 213.31 feet to a found iron rod on the east line of said Section 27 marking the southeast corner of said Nantucket Greene parcel;

thence S 00° 31' 08" E along the east line of said Section 27 a distance of 84.00 feet to a found iron rod on the north line of said Bastel parcel;

thence S 58° 39' 45" W along the north line of said Bastel parcel a distance of 203.76 feet to a found iron rod marking the northwest corner of said Bastel parcel;

thence S 00° 31' 08" E along the west line of said Bastel parcel a distance of 200.00 feet to the **POINT OF BEGINNING**.

thence continuing S 88° 50' 06" W along the south line of said Section 27 a distance of 351.00 feet to a found iron rod;

thence N 00° 31' 08" W a distance of 386.42 feet to a found iron rod marking the southwest corner of a parcel of land currently owned by Nantucket Greene Limited Partnership;

thence N 88° 50' 06" E along the south line of said Nantucket Greene parcel a distance of 217.29 feet to a set iron rod on the right-of-way line of a proposed street (Nantucket Drive);
