COMMENCING AT RAILROAD SPIKE FOUND OVER A STONE AND MONUMENT BOX [THIS SPIKE IS REFERENCED TO A PERSONALIZED HALF INCH DIAMETER IRON PIPE SET NORTH 0 DEGREES EAST AND 20.00 FEET DISTANT] AT THE INTERSECTION OF THE WEST LINE OF SAID SECTION WITH THE CENTERLINE OF TOWNSHIP HIGHWAY 55.

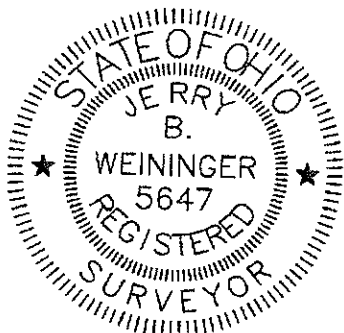

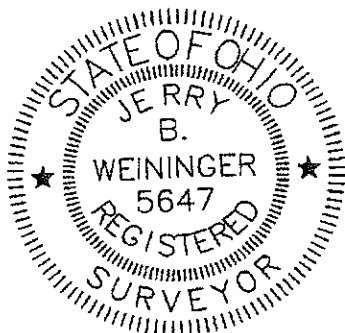
