thence on an assumed bearing of N 00° 25' 27" W along the centerline of County Highway 128 a distance of 35.00 feet to a found MAG nail on the north line of a parcel of land currently owned by the State of Ohio (State Route 182) and being the **POINT OF BEGINNING**, referenced by a found iron rod situated N 89° 47' 20" E a distance of 20.00 feet;

thence continuing N 00° 25' 27" W along said centerline a distance of 526.27 feet to a set MAG nail;

thence N 89° 47' 24" E a distance of 678.65 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 00° 25' 27" E a distance of 526.26 feet to a found iron rod on the north line of said State of Ohio parcel (State Route 182);

thence N 83° 56' 02" W along the north line of said State of Ohio parcel (State Route 182) a distance of 109.75 feet to a found iron rod;
