Commencing at a found stone in a monument box marking the Southeast Corner of said Section 11 and being the **POINT OF BEGINNING**;

thence on an assumed bearing of N 89° 52' 35" W along the centerline of Township Highway 44 a distance of 486.53 feet to a set MAG nail;

thence N 00° 00' 00" E a distance of 448.56 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence S 89° 52' 35" E a distance of 486.53 feet to a set MAG nail on the centerline of County Highway 91, passing a set iron rod a distance of 466.53 feet;

thence S 00° 00' 00" W along said centerline a distance of 448.56 feet to the **POINT OF BEGINNING**.

Containing in all 5.010 acres of land, more or less, of which 0.430 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

thence S 87° 40' 50" E a distance of 486.93 feet to a set MAG nail on the centerline of County Highway 91, passing a set iron rod a distance of 466.91 feet;

thence S 00° 00' 00" W along said centerline a distance of 448.56 feet to the **POINT OF BEGINNING**.
