Commencing at a found wood post marking the northwest corner of said Section 36 and being the **POINT OF BEGINNING**, referenced by a set iron rod situated S 00° 09' 35" W a distance of 2.00 feet;

thence on an assumed bearing of N 89° 55' 58" E along the north line of said Section 36 a distance of 657.96 feet to a set iron rod marking the northwest corner of a parcel of land currently owned by T. Shaw, Jr., et ux;

thence S 00° 05' 33" W along the west line of said Shaw parcel a distance of 1303.19 feet to a set iron rod, passing a set iron rod a distance of 1065.19 feet;

thence N 89° 40' 56" W a distance of 619.48 feet to a set iron rod, passing a set iron rod a distance of 309.48 feet;

thence S 00° 09' 35" W a distance of 1311.43 feet to a set iron rod on the north line of a parcel of land currently owned by the State of Ohio (State Route 182);

thence S 89° 33' 58" W along the north line of said State of Ohio parcel (State Route 182) a distance of 40.00 feet to a found iron rod on the west line of said Section 36;

thence N 00° 09' 35" E along the west line of said Section 36 a distance of 2610.72 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 2608.72 feet.

Containing in all 20.878 acres of land, more or less, being subject to all legal highways and easements of record.

thence on an assumed bearing of N 89° 55' 58" E along the north line of said Section 36 a distance of 657.96 feet to a set iron rod marking the northeast corner of a parcel of land currently owned by D. Courtad and being the **POINT OF BEGINNING**;

thence continuing N 89° 55' 58" E along the north line of said Section 36 a distance of 657.96 feet to a point marking the northwest corner of a parcel of land currently owned by C. W. Dirmeyer, passing a set iron rod a distance of 654.96 feet;

thence S 00° 01' 30" W along the west line of said Dirmeyer parcel a distance of 1061.65 feet to a set iron rod;

thence S 89° 37' 32" W a distance of 659.23 feet to a set iron rod on the east line of said Courtad parcel, passing a set iron rod a distance of 329.23 feet;
