Commencing at a found stone in a monument box marking the Southwest Corner of said Section 14;

thence on an assumed bearing of N 00° 00' 00" E along the centerline of Township Highway 104 a distance of 1744.88 feet to a set MAG nail marking the northwest corner of a parcel of land currently owned by Lyle and Lori Weaver and being the **POINT OF BEGINNING**, referenced by a set iron rod situated S 89° 29' 00" E a distance of 20.00 feet;

thence continuing N 00° 00' 00" E along said centerline a distance of 16.77 feet to a set MAG nail;

thence S 89° 29' 00" E a distance of 429.19 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 00° 00' 00" E a distance of 83.47 feet to a set iron rod;

thence S 89° 29' 00" E a distance of 289.02 feet to a set iron rod;

thence S 00° 00' 00" W a distance of 100.24 feet to a set iron rod on the north line of the aforementioned Weaver parcel;

thence N 89° 29' 00" W along the north line of said Weaver parcel a distance of 718.21 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 698.21 feet.

Containing in all 0.830 acre of land, more or less, of which 0.008 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.
