LEGAL DESCRIPTION OF A 3.008 ACRE PARCEL

Being a parcel of land situated in part of the Northeast Quarter of Section 29, T-3-S,  
R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found nail marking the intersection of the centerline of Township  
Highway 97 and the east-west half section line of said Section 29, referenced by a found  
iron rod situated S 87° 25' 00" W a distance of 20.00 feet;

thence on an assumed bearing of N 02° 35' 00" E along the centerline of Township  
Highway 97 a distance of 1052.88 feet to a found iron pipe;

thence N 21° 47' 05" E continuing along said centerline a distance of 386.64 feet to a  
found iron pipe;

thence N 08° 03' 22" W continuing along said centerline a distance of 302.07 feet to a set  
MAG nail and being the **POINT OF BEGINNING**, passing a found nail a distance of  
278.29 feet;

thence S 78° 42' 03" W a distance of 217.62 feet to a set iron rod, passing a set iron rod a  
distance of 20.03 feet;

thence S 33° 13' 09" W a distance of 139.43 feet to a set iron rod;

thence S 87° 30' 35" W a distance of 240.02 feet to a set iron rod on the east line of a  
parcel of land currently owned by A. Crow, et ux;

thence N 02° 35' 47" W along the east line of said Crow parcel a distance of 287.87 feet  
to a found iron rod marking a corner of said Crow parcel;

thence N 84° 52' 09" E along a line of said Crow parcel a distance of 137.50 feet to a  
found wood post marking the southwest corner of a parcel of land currently owned by D.  
DeBolt, passing a found iron rod a distance of 132.50 feet;

thence N 81° 55' 59" E along the south line of said DeBolt parcel a distance of 383.42  
feet to a set MAG nail on the centerline of Township Highway 97, passing a set iron rod  
a distance of 363.42 feet;

thence S 08° 03' 22" E along said centerline a distance of 185.80 feet to the **POINT OF  
BEGINNING**.

iron rod situated S 87° 25' 00" W a distance of 20.00 feet;

thence on an assumed bearing of N 02° 35' 00" E along the centerline of Township  
Highway 97 a distance of 1052.88 feet to a found iron pipe;

thence N 21° 47' 05" E continuing along said centerline a distance of 386.64 feet to a  
found iron pipe;

thence N 08° 03' 22" W continuing along said centerline a distance of 117.07 feet to a  
point marking the most northeasterly corner of a parcel of land currently owned by  
T. Groves, et ux, and being the **POINT OF BEGINNING**;

thence S 79° 11' 08" W along the northerly line of said Groves parcel a distance of  
128.71 feet to a set iron rod, passing a found nail a distance of 0.19 feet and a set iron rod  
a distance of 20.02 feet;

thence S 19° 42' 55" W continuing along the northerly line of said Groves parcel a
