Being a parcel of land situated in part of the Southwest Quarter of Section 12, T-1-S, R-12-E, Ridge Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the intersection of the centerline of Township Highway 22 and the west line of said Section 12;

thence on an assumed bearing of S 59° 00' 39" E along the centerline of Township Highway 22 a distance of 789.62 feet to a found railroad spike, referenced by a set iron rod situated N 36° 34' 54" E a distance of 30.06 feet;

thence S 57° 11' 06" E continuing along said centerline a distance of 255.09 feet to a found MAG nail and being the **POINT OF BEGINNING**, passing a found nail a distance of 215.00 feet;

thence N 36° 34' 54" E a distance of 268.27 feet to a point, passing 2 found iron rods a distance of 30.06 feet and 250.49 feet respectively;

thence S 57° 11' 06" E a distance of 269.48 feet to a point;

thence S 33° 58' 33" W a distance of 267.75 feet to a found MAG nail on the centerline of Township Highway 22, passing 2 set iron rods a distance of 17.75 feet and 237.74 feet respectively;

thence N 57° 11' 06" W along said centerline a distance of 281.68 feet to the **POINT OF BEGINNING**.

Containing in all 1.694 acres of land, more or less, of which 0.194 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

thence on an assumed bearing of S 59° 00' 39" E along the centerline of Township Highway 22 a distance of 789.62 feet to a found railroad spike, referenced by a found iron rod situated N 36° 34' 54" E a distance of 30.06 feet;

thence S 57° 11' 06" E continuing along said centerline a distance of 536.77 feet to a found MAG nail and being the **POINT OF BEGINNING**, passing a found nail a distance of 215.00 feet and a found MAG nail a distance of 255.09 feet;

thence N 33° 58' 33" E a distance of 267.75 feet to a point, passing 2 found iron rods a distance of 30.01 feet and 250.00 feet respectively;

thence S 57° 11' 06" E a distance of 275.97 feet to a point on the extended west line of a parcel of land currently owned by J. K. Coldiron;

thence S 33° 58' 33" W along said line a distance of 267.75 feet to a found MAG nail on the centerline of Township Highway 22 marking the southwest corner of said Coldiron parcel, passing 2 found iron rods a distance of 17.75 feet and 237.74 feet respectively;

thence N 57° 11' 06" W along said centerline a distance of 275.97 feet to the **POINT OF BEGINNING**.
