**LEGAL DESCRIPTION OF A 5.011 ACRE PARCEL

Being a parcel of land situated in part of the Northwest Quarter of Section 17, T-2-S, R-13-E, Salem Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the Northwest Corner of said Section 17;

thence on an assumed bearing of S 00° 03' 19" E along the centerline of County Highway 96 a distance of 377.00 feet to a set MAG nail and being the **POINT OF BEGINNING**;

thence S 90° 00' 00" E a distance of 60.00 feet to a point on or near the centerline of Baughman Run, passing a set iron rod a distance of 30.00 feet;

thence S 02° 39' 22" E on or near the centerline of Baughman Run a distance of 22.00 feet to a point, referenced by a set iron rod situated S 43° 42' 26" E a distance of 24.30 feet;

thence S 80° 52' 31" E continuing on or near the centerline of Baughman Run a distance of 32.50 feet to a point, referenced by a set iron rod situated S 50° 56' 46" W a distance of 19.70 feet;

thence S 60° 35' 06" E continuing on or near the centerline of Baughman Run a distance of 65.00 feet to a point, referenced by a set iron rod situated S 49° 48' 28" W a distance of 22.50 feet;

thence S 25° 34' 43" E continuing on or near the centerline of Baughman Run a distance of 82.00 feet to a point, referenced by a set iron rod situated S 16° 45' 20" W a distance of 27.50 feet;

thence S 43° 07' 13" E continuing on or near the centerline of Baughman Run a distance of 17.00 feet to a point, referenced by a set iron rod situated S 54° 32' 18" W a distance of 24.00 feet;

thence N 45° 36' 45" E continuing on or near the centerline of Baughman Run a distance of 58.00 feet to a point, referenced by a set iron rod situated S 11° 43' 51" E a distance of 26.50 feet;

thence S 85° 25' 37" E continuing on or near the centerline of Baughman Run a distance of 16.50 feet to a point, referenced by a set iron rod situated S 24° 10' 51" W a distance of 27.00 feet;

thence S 19° 27' 07" E continuing on or near the centerline of Baughman Run a distance of 188.00 feet to a point, referenced by a set iron rod situated S 73° 45' 00" W a distance of 32.00 feet;

thence S 59° 58' 28" W continuing on or near the centerline of Baughman Run a distance of 44.00 feet to a point, referenced by a set iron rod situated N 29° 26' 40" E a distance of 15.00 feet;

thence N 80° 32' 03" W continuing on or near the centerline of Baughman Run a distance of 28.00 feet to a point, referenced by a set iron rod situated N 76° 24' 44" E a distance of 36.00 feet;

thence S 39° 30' 12" W continuing on or near the centerline of Baughman Run a distance of 57.00 feet to a point, referenced by a set iron rod situated N 37° 18' 39" W a distance of 23.50 feet;

thence S 87° 45' 05" W continuing on or near the centerline of Baughman Run a distance of 27.00 feet to a point, referenced by a set iron rod situated N 32° 48' 50" E a distance of 23.50 feet;

thence S 27° 03' 52" W continuing on or near the centerline of Baughman Run a distance of 103.00 feet to a point, referenced by a set iron rod situated N 50° 19' 06" W a distance of 32.00 feet;

thence S 62° 29' 45" W continuing on or near the centerline of Baughman Run a distance of 95.00 feet to a point, referenced by a set iron rod situated N 80° 41' 50" W a distance of 22.50 feet;

thence S 28° 19' 33" W continuing on or near the centerline of Baughman Run a distance of 26.00 feet to a point, referenced by a set iron rod situated N 20° 24' 22" W a distance of 28.30 feet;

thence S 56° 14' 19" W continuing on or near the centerline of Baughman Run a distance of 144.00 feet to a point, referenced by a set iron rod situated N 60° 25' 46" W a distance of 56.17 feet;

thence N 86° 13' 11" W continuing on or near the centerline of Baughman Run a distance of 79.00 feet to a set MAG nail on the centerline of County Highway 96, referenced by a set iron rod situated N 53° 05' 58" E a distance of 37.49 feet;

thence N 00° 03' 19" W along said centerline a distance of 760.00 feet to the **POINT OF BEGINNING**.

Containing in all 5.011 acres of land, more or less, of which 0.523 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
