**LEGAL DESCRIPTION FOR McCREARY ESTATES
1.698 ACRE TRACT
MIFFLIN TOWNSHIP, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, TOWNSHIP OF MIFFLIN, AND BEING PART OF THE SOUTHEAST QUARTER OF SECTION 25, TOWNSHIP 3 SOUTH, RANGE 13 EAST, BEING A 1.698 ACRE TRACT OUT OF AN ORIGNAL TRACT CONVEYED TO NELLIE TAYLOR, L.E., ETAL. OF RECORD IN DEED BOOK 103, PAGE 430, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING FOR REFERENCE AT A STONE AND MONUMENT BOX FOUND MARKING THE NORTHEAST CORNER OF SAID SECTION 25, WHICH POINT ALSO MARKS THE INTERSECTION OF THE CENTERLINE OF TOWNSHIP HIGHWAY 65 WITH THE EAST RIGHT OF WAY LINE OF COUNTY HIGHWAY 109 (33 FEET IN WIDTH);

THENCE ON AN ASSUMED BEARING OF SOUTH 00 DEGREES 00 MINUTES 00 SECONDS EAST, A DISTANCE OF 3,450.18 FEET ALONG THE EAST LINE OF SAID SECTION 25 AND EAST RIGHT OF WAY LINE OF COUNTY HIGHWAY 109 TO A 5/8 INCH IRON PIN FOUND MARKING THE POINT OF BEGINNING;

THENCE CONTINUING SOUTH 00 DEGREES 00 MINUTES 00 SECONDS EAST, A DISTANCE OF 260.00 FEET ALONG THE EAST LINE OF SAID SECTION 25 AND EAST RIGHT OF WAY LINE OF SAID COUNTY HIGHWAY 109 TO A 5/8 INCH IRON PIN FOUND;

THENCE NORTH 90 DEGREES 00 MINUTES 00 SECONDS WEST, A DISTANCE OF 284.40 FEET OVER AND ACROSS SAID TAYLOR TRACT (PASSING OVER A 5/8 INCH IRON PIN FOUND AT 33.00 FEET, AND AT 190.00) TO A 5/8 INCH IRON PIN SET;

THENCE NORTH 00 DEGREES 00 MINUTES 00 SECONDS WEST, A DISTANCE OF 260.00 FEET CONTINUING OVER AND ACROSS SAID TAYLOR TRACT TO A 5/8 INCH IRON PIN SET;


THENCE SOUTH 90 DEGREES 00 MINUTES 00 SECONDS EAST A DISTANCE OF 284.40 FEET CONTINUING OVER AND ACROSS SAID TAYLOR TRACT (PASSING OVER A 5/8 INCH IRON PIN FOUND AT 94.40 FEET, AND AT 251.40 FEET) TO THE 5/8 INCH IRON PIN FOUND ON THE EAST LINE OF SAID SECTION 25 AND EAST RIGHT OF WAY LINE OF COUNTY HIGHWAY 109 AND MARKING THE POINT OF BEGINNING, CONTAINING 1.698 ACRES OF LAND, OF WHICH 0.197 ACRES ARE IN THE RIGHT-OF-WAY OF SAID COUNTY HIGHWAY 109, MORE OR LESS.
