thence on an assumed bearing of S 00° 00' 00" W along the centerline of Township Highway 136 a distance of 888.54 feet to a found MAG nail marking the southwest corner of a parcel of land currently owned by K. & A. Beamer and being the **POINT OF BEGINNING**, passing a found MAG nail a distance of 679.83 feet;

thence S 90° 00' 00" E along the south line of said Beamer parcel a distance of 240.00 feet to a set iron rod, passing a found iron pipe a distance of 20.00 feet;

thence S 00° 00' 00" W a distance of 154.29 feet to a set iron rod;

thence N 90° 00' 00" W a distance of 240.00 feet to a set MAG nail on the centerline of Township Highway 136, passing a set iron rod a distance of 220.00 feet;

thence N 00° 00' 00" E along said centerline a distance of 154.29 feet to the **POINT OF BEGINNING**.

Containing in all 0.850 acre of land, more or less, of which 0.071 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.
