SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, BEING PART OF THE NORTHEAST QUARTER OF FRACTIONAL SECTION 5, TOWNSHIP 4 SOUTH, RANGE 15 EAST, ANTRIM TOWNSHIP, BEING A 9.102 ACRE TRACT OUT OF A TRACT CONVEYED TO R. DENNIS RHODES OF RECORD IN DEED BOOK 191, PAGE 875, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING FOR REFERENCE AT A RAILROAD SPIKE FOUND OVER A STONE AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID FRACTIONAL SECTION 5, SAID RAILROAD SPIKE ALSO BEING AT THE CENTERLINE INTERSECTION OF TOWNSHIP HIGHWAY 72 (40 FEET IN WIDTH), AND TOWNSHIP HIGHWAY 135a (40 FEET IN WIDTH);

THENCE NORTH  $00^{\circ}09'59''$  EAST, A DISTANCE OF 1282.40 FEET WITH THE CENTERLINE OF SAID TOWNSHIP HIGHWAY 135a, AND THE EAST LINE OF SAID FRACTIONAL SECTION 5 TO A RAILROAD SPIKE FOUND OVER A STONE AT THE POINT OF BEGINNING, SAID RAILROAD SPIKE BEING REFERENCED BY A  $5/8''$  IRON PIN SET SOUTH  $89^{\circ}52'49''$  WEST, A DISTANCE OF 20.00 FEET, SAID RAILROAD SPIKE ALSO BEING AT A SOUTHEAST CORNER OF SAID RHODES TRACT, AND AT A NORTHEAST CORNER OF A TRACT CONVEYED TO MAKEN BACON FARMS INC. OF RECORD IN DEED BOOK 168, PAGE 317;

THENCE SOUTH  $89^{\circ}52'49''$  WEST, A DISTANCE OF 712.29 FEET WITH THE SOUTH LINE OF SAID RHODES TRACT AND A NORTH LINE OF SAID MAKEN BACON FARMS INC. TRACT, PASSING SAID IRON PIN SET AT 20.00 FEET, TO A  $5/8''$  IRON PIN SET;

THENCE NORTH  $00^{\circ}09'50''$  WEST, A DISTANCE OF 630.33 FEET WITH A WEST LINE OF SAID RHODES TRACT, AND AN EAST LINE OF SAID MAKEN BACON FARMS INC. TRACT TO A  $5/8''$  IRON PIN SET ON THE SOUTH LINE OF A TRACT CONVEYED TO GERALD SHEAFFER, LE, ETAL OF RECORD IN OFFICIAL RECORD 135, PAGE 684;

THENCE SOUTH  $89^{\circ}59'00''$  EAST, A DISTANCE OF 503.58 FEET WITH A NORTH LINE OF SAID RHODES TRACT, A SOUTH LINE OF SAID SHEAFFER TRACT, AND A SOUTH LINE OF A TRACT CONVEYED TO WILLIAM D. GRAHAM, ETAL OF RECORD IN DEED BOOK 199, PAGE 314, & DEED BOOK 182, PAGE 167 TO A  $5/8''$  IRON PIN SET;

THENCE SOUTH  $00^{\circ}09'50''$  EAST, A DISTANCE OF 248.71 FEET WITH AN EAST LINE OF SAID RHODES TRACT, AND A WEST LINE OF SAID GRAHAM TRACT, PASSING A  $5/8''$  IRON PIN SET AT 208.71 FEET, TO A  $5/8''$  IRON PIN SET;

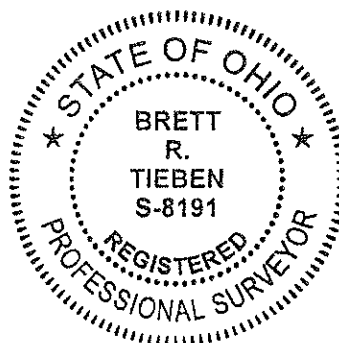

DENNIS RHODES OF RECORD IN DEED BOOK 191, PAGE 875, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING FOR REFERENCE AT A RAILROAD SPIKE FOUND OVER A STONE AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SAID FRACTIONAL SECTION 5, SAID RAILROAD SPIKE ALSO BEING AT THE CENTERLINE INTERSECTION OF TOWNSHIP HIGHWAY 72 (40 FEET IN WIDTH), AND TOWNSHIP HIGHWAY 135a (40 FEET IN WIDTH);

THENCE NORTH 00°09'59" EAST, A DISTANCE OF 1282.40 FEET WITH THE CENTERLINE OF SAID TOWNSHIP HIGHWAY 135a, AND THE EAST LINE OF SAID FRACTIONAL SECTION 5 TO A RAILROAD SPIKE FOUND OVER A STONE, SAID RAILROAD SPIKE BEING REFERENCED BY A 5/8" IRON PIN SET SOUTH 89°52'49" WEST, A DISTANCE OF 20.00 FEET, SAID RAILROAD SPIKE ALSO BEING AT A SOUTHEAST CORNER OF SAID RHODES TRACT, AND AT A NORTHEAST CORNER OF A TRACT CONVEYED TO MAKEN BACON FARMS INC.
