Beginning for a point of reference at a PK Nail found at the intersection of the centerlines of old U. S. Route 30 (currently County Highway 330) and Township Highway 124 (40' wide), said PK nail being referenced by an iron pin found at S 18° 49' 06" W at 61.69 feet;

thence, S 00° 05' 51" E, 651.18 feet along the centerline of said Township Highway 124 to a PK nail set, said PK nail being referenced by an Iron Pin and Cap found at S 89° 58' 52" W, 20.25 feet, and being the northeasterly corner of Parcel 2 of said Bastel lands, the southeasterly corner of a tract of land conveyed to Rock Run, LLC, as recorded in Official Record Volume 27, page 843 and the true point of beginning of the herein described parcel:

thence, S 00° 05' 51" E, 229.86 feet continuing with the centerline of said Township Highway 124, the easterly line of said Bastel lands and the easterly line of said Erie Land Co., LLC lands, passing a PK nail set at 194.86 feet on the southeasterly corner of Parcel 1 of said Bastel lands and the northeasterly corner of said Erie Land Co., LLC lands to a PK nail set, said PK nail being referenced by a 5/8 inch Iron Pin and Cap found at S 89° 58' 00" W, 20.00 feet;

thence, S 89° 58' 00" W, 215.62 feet running through said Erie Land Co., LLC lands, passing a 5/8 inch Iron Pin and Cap set at 20.00 feet on the westerly right-of-way line of said Township Highway 124 and a 5/8 inch Iron Pin and Cap set for reference at 30.00 feet to a 5/8 inch Iron Pin and Cap set;

thence, N 00° 02' 22" E, 229.91 feet running with said Erie Land Co., LLC lands and the westerly line of said Bastel lands (Parcel 1 and Parcel 2), passing a 5/8 inch Iron Pin and Cap found at 35.00 feet on the southwesterly corner of said Bastel lands (Parcel 1) and a 5/8 inch Iron Pin found at 214.91 feet (0.12 feet west) to a 5/8 inch Iron Pin and Cap found on the northwesterly corner of Parcel 2 and on the southerly line of a tract of land conveyed to Rock Run LLC, as recorded in Official Record Volume 27, page 843;

thence, S 00° 05' 51" E, 846.04 feet along the centerline of said Township Highway 124 to a PK nail set, said PK nail being referenced by an iron pin found at S 89° 58' 00" W, 20.00 feet and being the northeasterly corner of said Erie Land Co., LLC lands, the southeasterly corner of a tract of land conveyed to David J. and Deborah L.
