Being a parcel of land situated in part of the Northeast and Southeast Quarters of Section 29 and the Northwest Quarter of Section 28, T-1-S, R-14-E, Tymochtee Township, Wyandot County, Ohio, and further described as follows:

Commencing at a railroad spike marking the intersection of the centerlines of State Route 53 and Township Highway 29;

thence on an assumed bearing of N 86° 30' 00" E along the centerline of Township Highway 29 a distance of 1801.12 feet to a railroad spike marking a northwesterly corner of a 11.222 acre parcel of land currently owned by Kalmbach Wagner Swine Research Farm and being the **POINT OF BEGINNING**;

thence continuing N 86° 30' 00" E along said centerline a distance of 110.82 feet to a P-K nail, passing a railroad spike a distance of 15.01 feet;

thence N 89° 17' 04" E along said centerline a distance of 117.89 feet to a P-K nail marking the northeasterly corner of 1.458 acre parcel of land currently owned by Kalmbach Wagner Swine Research Farm;

thence S 03° 48' 10" W along the east line of said 1.458 acre parcel a distance of 169.63 feet to an iron rod, passing an iron rod a distance of 20.06 feet;

thence S 13° 21' 09" W along the east line of said 1.458 acre parcel a distance of 199.51 feet to an iron rod marking the southeasterly corner of said 1.458 acre parcel;

thence N 86° 38' 40" W along the south line of said 1.458 acre parcel a distance of 30.42 feet to an iron rod marking the northeasterly corner of a 0.775 acre parcel of land currently owned by Kalmbach Wagner Swine Research Farm;

thence S 03° 21' 20" W along the east line of said 0.775 acre parcel a distance of 391.67 feet to an iron rod marking the southeast corner of said 0.775 acre parcel;

thence N 86° 38' 40" W along the south line of said 0.775 acre parcel a distance of 90.00 feet to an iron rod marking the northeast corner of a 1.594 acre parcel of land currently owned by M. P. Kalmbach, et ux;

thence S 03° 21' 20" W along the east line of said 1.594 acre parcel a distance of 330.65 feet to an iron rod marking the southeast corner of said 1.594 acre parcel;

thence S 03° 21' 20" W along the east line of said 5.372 acre parcel a distance of 450.00 feet to an iron rod marking the southeast corner of said 5.372 acre parcel;

thence N 86° 38' 40" W along the south line of said 5.372 acre parcel a distance of 520.00 feet to an iron rod marking the southwest corner of said 5.372 acre parcel;

thence N 03° 21' 20" E along the west line of said 5.372 acre parcel and the west line of the aforementioned 11.222 acre parcel a distance of 1200.00 feet to an iron rod marking a northwesterly corner of said 11.222 acre parcel, passing an iron rod a distance of 450.00 feet;

thence S 86° 38' 40" E along a northerly line of said 11.222 acre parcel a distance of 675.36 feet to an iron rod marking a corner of said 11.222 acre parcel;

thence N 00° 21' 20" E along an westerly line of said 11.222 acre parcel a distance of 317.27 feet to the **POINT OF BEGINNING**.

Commencing at a found railroad spike marking the intersection of the centerlines of State
Route 53 and Township Highway 29, referenced by a set iron rod situated S 50° 18' 57"
E a distance of 31.32 feet;

thence on an assumed bearing of S 02° 38' 02" W along the centerline of State Route 53
a distance of 2320.59 feet to a found P-K- nail marking the northwest corner of a parcel
of land currently owned by James Wagner, et ux and being the **POINT OF
BEGINNING**;

thence S 87° 43' 40" E along the north line of said Wagner parcel a distance of 468.13
feet to a found iron rod marking the northeast corner of said Wagner parcel, passing 2
found iron pipes a distance of 29.35 feet and 255.13 feet respectively;

thence S 02° 04' 08" W along the east line of said Wagner parcel a distance of 304.17
feet to a found iron rod marking the southeast corner of said Wagner parcel;

thence N 87° 46' 07" W along the south line of said Wagner parcel a distance of 471.18
feet to a set MAG nail on the centerline of State Route 53 marking the southwest corner
of said Wagner parcel, passing 2 found iron pipes a distance of 213.00 feet and 441.79
feet respectively;

thence N 02° 38' 32" E along said centerline a distance of 304.51 feet to the **POINT OF
BEGINNING**.

Containing in all 3.281 acres of land, more or less, of which 0.175 acre, more or less, is
currently contained within highway right-of-ways. The above described property being
subject to all legal highways and easements of record.
