LEGAL DESCRIPTION OF A 1.000 ACRE PARCEL  
FOR JASON GETZ

Being a parcel of land situated in part of the Northwest Quarter of Section 13, T-3-S,  
R-14-E, Pitt Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found railroad spike marking the West Quarter Post of said Section 13,  
referenced by a found iron rod situated S 89° 21' 53" E a distance of 20.00 feet;

thence on an assumed bearing of N 00° 15' 53" E along the centerline of Township  
Highway 127 a distance of 375.00 feet to a found MAG nail marking the northwest  
corner of a parcel of land currently owned by J. Getz, et ux, and being the **POINT OF  
BEGINNING**, referenced by a found iron rod situated S 89° 21' 53" E a distance of  
20.00 feet;

thence continuing N 00° 15' 53" E along said centerline a distance of 65.00 feet to a  
found MAG nail marking the southwest corner of another parcel of land currently owned  
by J. Getz, et ux;

thence S 89° 21' 53" E along the south line of said latter Getz parcel a distance of 175.00  
feet to a found iron rod marking the southeast corner of said parcel, passing a found iron  
rod for reference a distance of 20.00 feet;

thence N 00° 15' 53" E along the east line of said Getz parcel a distance of 375.00 feet to  
a found iron rod marking the northeast corner of said parcel;

thence S 89° 21' 53" E a distance of 39.49 feet to a set iron rod;

thence S 00° 15' 53" W a distance of 815.00 feet to a set iron rod on the east-west half  
section line;

thence N 89° 21' 53" W along said half section line a distance of 39.49 feet to a found  
iron rod marking the southeast corner of the former mentioned parcel of land currently  
owned by J. Getz, et ux;

thence N 00° 15' 53" E along the east line of said Getz parcel a distance of 375.00 feet to  
a found iron rod marking the northeast corner of said parcel;

thence N 89° 21' 53" W along the north line of said Getz parcel a distance of 175.00 feet  
to the **POINT OF BEGINNING**, passing a found iron rod for reference a distance of  
155.00 feet.
