Commencing at a found stone in a monument box marking the South Quarter Post of said Section 28;

thence on an assumed bearing of S 90° 00' 00" E along the centerline of County Highway 36 a distance of 707.98 feet to a set MAG nail and being the **POINT OF BEGINNING**;

thence N 00° 00' 00" E a distance of 337.40 feet to a set iron rod, passing a set iron rod for reference a distance of 30.00 feet;

thence S 90° 00' 00" E a distance of 387.06 feet to a set iron rod;

thence S 00° 05' 02" E a distance of 217.51 feet to a set iron rod marking the northeast corner of a 0.589 acre parcel of land currently owned by R. E. Aurand, et ux;

thence S 89° 54' 47" W along the north line of said 0.589 acre parcel a distance of 214.59 feet to a set iron rod marking the northwest corner of said parcel;

thence S 00° 30' 42" E along the west line of said 0.589 acre parcel a distance of 119.58 feet to a point on the centerline of County Highway 36 marking the southwest corner of said parcel, passing a set iron rod for reference a distance of 89.58 feet and a found railroad spike a distance of 119.48 feet;

thence S 90° 00' 00" W along said centerline a distance of 173.85 feet to the **POINT OF BEGINNING**.

thence N 00° 00' 00" E a distance of 337.40 feet to a set iron rod, passing a set iron rod for reference a distance of 30.00 feet;

thence S 90° 00' 00" E a distance of 387.06 feet to a set iron rod;

thence S 00° 35' 02" E a distance of 337.41 feet to a point marking the southeast corner of a 0.589 acre parcel of land currently owned by R. E.
