CITY OF UPPER SANDUSKY, WYANDOT COUNTY, OHIO**

SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, CITY OF UPPER SANDUSKY, AND BEING PART OF LOT 11 OF HIGHLAND ACRES SUBDIVISION NO. 6, AND BEING A 0.002 ACRE TRACT OUT OF AN ORIGINAL TRACT CONVEYED TO BRIDGESTONE APM COMPANY OF RECORD IN OFFICIAL RECORD 204, PAGE 2412, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING FOR REFERENCE AT AN IRON PIN FOUND AT A NORTHWEST CORNER OF HIGHLAND SUBDIVISION NO. 6, LOT 11, A NORTHWEST CORNER OF SAID BRIDGESTONE APM COMPANY, A NORTHEAST CORNER OF HIGHLAND SUBDIVISION NO. 6, LOT 9, A NORTHEAST CORNER OF A TRACT CONVEYED TO THE CITY OF UPPER SANDUSKY OF RECORD IN OFFICIAL RECORD 162, PAGE 424, AND ON THE SOUTH RIGHT-OF-WAY LINE OF COMMERCE WAY (80 FEET IN WIDTH);

THENCE SOUTH 14°59'17" WEST, A DISTANCE OF 92.45 FEET WITH A WESTERLY LINE OF SAID LOT 11 AND BRIDGESTONE TRACT AND AN EASTERLY LINE OF SAID LOT 9 AND SAID CITY OF UPPER SANDUSKY TRACT, TO AN IRON PIN FOUND AT A NORTHWESTERLY CORNER OF SAID LOT 11 AND BRIDGESTONE TRACT AND A SOUTHEASTERLY CORNER OF SAID LOT 9 AND CITY OF UPPER SANDUSKY TRACT, SAID IRON PIN FOUND BEING THE POINT OF BEGINNING;

THENCE CONTINUING SOUTH 14°59'17" WEST, A DISTANCE OF 19.02 FEET OVER AND ACROSS SAID LOT 11 AND BRIDGESTONE TRACT, WITH A NEW LINE, TO AN IRON PIN SET ON THE SOUTHWESTERLY LINE OF SAID LOT 11 AND BRIDGESTONE TRACT AND A NORTHEASTERLY LINE OF HIGHLAND SUBDIVISION NO. 8, LOT 2, CONVEYED TO UPPER UNITED DEVELOPMENT CORPORATION OF RECORD IN DEED BOOK 146, PAGE 146;

THENCE NORTH 43°39'27" WEST, A DISTANCE OF 9.90 FEET WITH A SOUTHWESTERLY LINE OF SAID LOT 11 AND BRIDGESTONE TRACT AND WITH A NORTHEASTERLY LINE OF SAID LOT 2 AND UPPER UNITED DEVELOPMENT TRACT, TO AN IRON PIN FOUND AT A NORTHWESTERLY CORNER OF SAID LOT 11 AND BRIDGESTONE TRACT, A NORTHERLY CORNER OF SAID LOT 2 AND UPPER UNITED DEVELOPMENT TRACT, AN ON A SOUTHEASTERLY LINE OF SAID LOT 9 AND CITY OF UPPER SANDUSKY TRACT;


