thence S 89° 37' 50" W for a distance of 1175.90 to a 5/8" dia. iron pin set on Grantor's West Line;

thence along Grantor's West Line N 0° 26' 55" W for a distance of 1681.19 feet to a 5/8" dia. iron pin set on the North Line of Section 7;

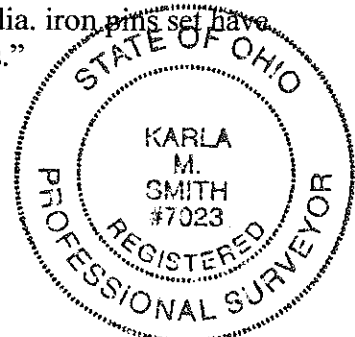

thence along said North-South Half Section Line S 0° 32' 20" E for a distance of 70.98 feet to a railroad spike set on the centerline of County Highway 113 (said point also being referenced by a 5/8" dia. iron pin set S 45° 17' 45" W at 30.00 feet);

thence along said centerline S 44° 42' 15" E (for basis of bearing, see O.D.O.T. centerline plan for WYA-23-0.20) for a distance of 165.22 feet to a railroad spike set and the point of beginning (being referenced by a 5/8" dia. iron pin set S 89° 37' 50" W at 58.00 feet);
