**LEGAL DESCRIPTION OF A 5.778 ACRE PARCEL
FOR CHRISTINE COPE**

Being a parcel of land situated in part of the Southeast and Southwest Quarters of Section 16, T-2-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the South Quarter Post of said Section 16 and being the **POINT OF BEGINNING**;

thence on an assumed bearing of N 89° 42' 01" W along the centerline of Township Highway 121 a distance of 14.92 feet to a found MAG nail marking the southeasterly corner of a parcel of land currently owned by C. Baker, et ux;

thence N 01° 28' 44" E along said Baker parcel a distance of 395.83 feet to a found iron rod, passing a found iron rod for reference a distance of 20.00 feet;

thence N 29° 29' 34" E along said Baker parcel a distance of 350.57 feet to a found iron rod;

thence N 48° 11' 52" E along said Baker parcel a distance of 262.79 feet to a found iron rod;

thence N 77° 46' 34" E along said Baker parcel a distance of 205.85 feet to a found nail on the centerline of County Highway 50, referenced by a found iron rod situated N 44° 49' 49" E a distance of 16.73 feet;

thence S 39° 51' 23" E along said centerline a distance of 84.55 feet to a found MAG nail, referenced by a found iron rod situated N 16° 21' 49" E a distance of 20.06 feet;

thence S 16° 12' 02" W along said centerline a distance of 551.74 feet to a set MAG nail;

thence N 88° 30' 36" W a distance of 411.59 feet to a set iron rod, passing a set iron rod for reference a distance of 20.68 feet;

thence S 01° 28' 44" W a distance of 335.92 feet to a found MAG nail on the centerline of Township Highway 121 marking the southwest corner of a parcel of land currently owned by E. W. and E. B. Carpenter, Trustees, passing 1 found iron rod and 2 found iron pipes for reference a distance of 100.00 feet, 135.00 feet and 315.92 feet respectively;

thence N 89° 47' 11" W along said centerline a distance of 45.09 feet to the **POINT OF BEGINNING**.

Containing in all 5.778 acres of land, more or less, of which 0.028 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

LEGAL DESCRIPTION OF A 0.915 ACRE PARCEL
FOR CHRISTINE COPE / ED CARPENTER

Being a parcel of land situated in part of the Southeast Quarter of Section 16, T-2-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone in a monument box marking the South Quarter Post of said Section 16;

thence on an assumed bearing of S 89° 47' 11" E along the centerline of Township Highway 121 a distance of 45.09 feet to a found MAG nail marking the southwest corner of a parcel of land currently owned by E. W. Carpenter and E. B. Carpenter, Trustees;

thence N 01° 28' 44" E along said Carpenter, Trustee parcel a distance of 235.92 feet to a found iron rod marking the northwest corner of said parcel and being the **POINT OF BEGINNING**, passing 2 found iron pipes for reference a distance of 20.00 feet and 200.92 feet respectively;

thence continuing N 01° 28' 44" E a distance of 100.00 feet to a set iron rod;

thence S 88° 30' 36" E a distance of 411.59 feet to a set MAG nail on the centerline of County Highway 50, passing a set iron rod for reference a distance of 390.91 feet;

thence S 16° 12' 02" W along said centerline a distance of 103.39 feet to a found nail marking the northeast corner of said Carpenter, Trustee parcel;
