SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, CITY OF UPPER SANDUSKY, SECTION 28, TOWNSHIP 2 SOUTH, RANGE 14 EAST, BEING PART OF THE SOUTHWEST QUARTER OF SAID SECTION, A 0.898 ACRE TRACT CONVEYED TO THOMAS A. AND CLARA R. SCHILLING, JTS OF RECORD IN OFFICIAL RECORD 220, PAGE 2536, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;

BEGINNING AT AN IRON PIN SET AT THE NORTHWEST CORNER OF LOT 17 OF RIVER'S EDGE SUBDIVISION, CONVEYED TO RUTH ANN FREY, OF RECORD IN OFFICIAL RECORD 219, PAGE 2428, THE EAST RIGHT-OF-WAY LINE OF PHEASANT RUN (60 FEET IN WIDTH), AND A SOUTHWEST CORNER OF SAID SCHILLING TRACT;

THENCE NORTH $33^{\circ}36'42''$ EAST, A DISTANCE OF 41.12 FEET WITH THE EAST RIGHT-OF-WAY LINE OF SAID PHEASANT RUN AND A WEST LINE OF SAID SCHILLING TRACT, TO AN IRON PIN SET;

THENCE WITH THE ARC OF A TANGENT CURVE TO THE LEFT HAVING AN RADIUS OF 180.00 FEET, A DELTA ANGLE OF $3^{\circ}06'45''$, AN ARC LENGTH OF 9.78 FEET, A CHORD OF WHICH BEARS NORTH $32^{\circ}03'19''$ EAST, A DISTANCE OF 9.78 FEET WITH THE EAST RIGHT-OF-WAY LINE OF SAID PHEASANT RUN AND A WEST LINE OF SAID SCHILLING TRACT, TO AN IRON PIN SET;

THENCE NORTH $59^{\circ}30'04''$ WEST, A DISTANCE OF 1.02 FEET WITH THE NORTHERLY RIGHT-OF-WAY LINE OF SAID PHEASANT RUN AND A SOUTH LINE OF SAID SCHILLING TRACT, TO AN IRON PIN SET AT A CORNER OF PROPOSED PHEASANT RUN (60 FEET IN WIDTH) AND A SOUTHEAST CORNER OF A TRACT CONVEYED TO NEW HAVEN INVESTMENTS, LLC OF RECORD IN DEED BOOK 216, PAGE 705;

THENCE WITH THE ARC OF A CURVE TO THE LEFT HAVING A RADIUS OF 180.00 FEET, A DELTA ANGLE OF $30^{\circ}22'52''$, AN ARC LENGTH OF 95.44 FEET, A CHORD OF WHICH BEARS NORTH $15^{\circ}10'00''$ EAST, A DISTANCE OF 94.33 FEET WITH THE WEST LINE OF SAID SCHILLING TRACT, THE EAST RIGHT-OF-WAY LINE OF PROPOSED PHEASANT RUN, AND AN EAST LINE OF A SAID NEW HAVEN INVESTMENTS TRACT, TO AN IRON PIN FOUND;

THENCE WITH THE ARC OF A TANGENT CURVE TO THE RIGHT HAVING A RADIUS OF 50.00 FEET, A DELTA ANGLE OF $28^{\circ}16'01''$, AN ARC LENGTH OF 24.67 FEET, A CHORD OF WHICH BEARS NORTH $14^{\circ}06'35''$ EAST, A DISTANCE OF 24.42 FEET WITH THE WEST LINE OF SAID SCHILLING TRACT, THE EAST RIGHT-OF-WAY LINE OF SAID PROPOSED PHEASANT RUN, AND AN EAST LINE OF SAID NEW HAVEN INVESTMENTS TRACT, TO AN IRON PIN FOUND;

THENCE WITH THE ARC OF A TANGENT CURVE TO THE LEFT HAVING A RADIUS OF 75.00 FEET, A DELTA ANGLE OF $52^{\circ}39'15''$, AN ARC LENGTH OF 68.92 FEET, A CHORD OF WHICH BEARS NORTH $01^{\circ}54'58''$ EAST, A DISTANCE OF 66.52 FEET WITH THE WEST LINE OF SAID SCHILLING TRACT, THE EAST LINE OF SAID PROPOSED PHEASANT RUN, AND AN EAST LINE OF SAID NEW HAVEN INVESTMENTS TRACT, TO AN IRON PIN FOUND;

THENCE NORTH $65^{\circ}35'21''$ EAST, A DISTANCE OF 117.01 FEET WITH THE NORTH LINE OF SAID SCHILLING TRACT AND A SOUTH LINE OF SAID NEW HAVEN INVESTMENTS TRACT, TO AN IRON PIN FOUND AT THE NORTHEAST CORNER OF SAID SCHILLING TRACT, A SOUTHEAST CORNER OF SAID NEW HAVEN INVESTMENTS TRACT, AND A WEST LINE OF A TRACT CONVEYED TO MATTHEW JOEL AND SUSAN McCARTHY SMITH, JTS OF RECORD IN OFFICIAL RECORD 228, PAGE 2553;

THENCE SOUTH $00^{\circ}06'53''$ EAST, A DISTANCE OF 383.65 FEET WITH THE EAST LINE OF SAID SCHILLING TRACT AND A WEST LINE OF SAID SMITH TRACT, TO AN IRON PIN FOUND AT A SOUTHEAST CORNER OF SAID SCHILLING TRACT AND A NORTHEAST CORNER OF LOT 18 OF SAID RIVER'S EDGE SUBDIVISION CONVEYED TO BRADLEY D. EHRMAN, ETUX, TRUSTEES OF RECORD IN OFFICIAL RECORD 201, PAGE 269;


