**LEGAL DESCRIPTION OF A 2.500 ACRE PARCEL**  
**FOR BRETT AND KATIE KUHN**

Being a parcel of land situated in part of the Northwest Quarter of Section 21, T-2-S, R-14-E, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod in concrete marking the northwest corner of said Section 21;

thence on an assumed bearing of S 89° 42' 01" E along the north line of said Section 21 a distance of 1319.75 feet to a found MAG nail, the **POINT OF BEGINNING** of the hereinafter described parcel, said nail referenced by a set iron rod bearing S 00° 08' 33" W a distance of 20.00 feet;

thence S 89° 42' 01" E along said north section a distance of 255.84 feet to a set MAG nail;

thence S 00° 08' 33" W a distance of 434.33 feet to a set iron rod, passing a set iron rod a distance of 20.00 feet;

thence N 85° 49' 30" W a distance of 256.47 feet to a set iron rod marking the east line of the west half of the northwest quarter of said Section 21 and being the east line of a parcel now or formerly owned by T. Koehler, Trustee, Etal.;

thence N 00° 08' 33" E along said line and the east line of a parcel now or formerly owned by C. Cooper a distance of 417.00 feet to the **POINT OF BEGINNING**, passing aforementioned set iron rod a distance of 397.00 feet.

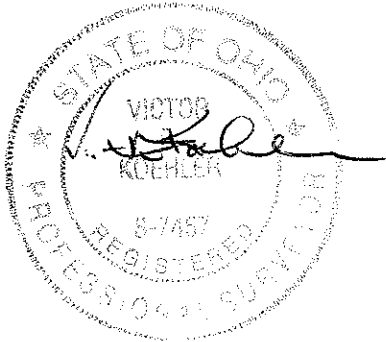
