thence on an assumed bearing of S 89° 54' 43" E along the south line of said Outlot #4 a distance of 125.00 feet to a set iron rod;

thence S 00° 16' 07" W on a line a distance of 8.00 feet to a set iron rod;

thence N 89° 54' 43" W on a line a distance of 125.00 feet to a set iron rod marking the east right-of-way line of Morrison State Road (AKA Morrison Street) ;

thence N 00° 16' 07" E along said east right-of-way line a distance of 8.00 feet to the **POINT OF BEGINNING.**

Containing in all 0.023 acres of land, being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

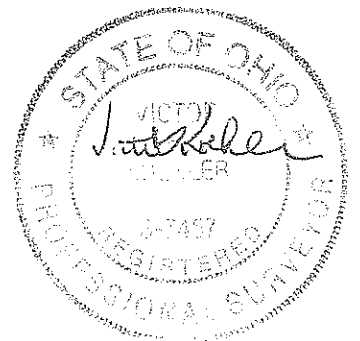

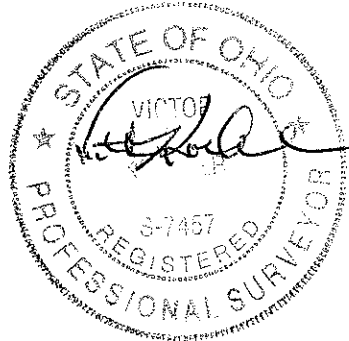
