**LEGAL DESCRIPTION OF A 4.429 ACRE PARCEL
FOR CLINTON YOUNG**

Being a parcel of land situated in the Southwest Quarter of Section 18, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Beginning at a found stone marking the south quarter post of said Section 18 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 89° 22' 06" W along the south line of said Section 18 and the centerline of County Highway 63 a distance of 468.00 feet to a found MAG nail marking the southeast corner of a parcel of land now or formerly owned by S. Young, Etux., referenced by a found iron rod situated N 02° 28' 56" E a distance of 25.01 feet;

thence N 02° 28' 56" E along the east line of said Young parcel a distance of 476.42 feet to a set iron rod;

thence N 70° 14' 09" E on a line a distance of 95.25 feet to a set iron rod;

thence S 58° 28' 57" E on a line a distance of 420.95 feet to a set iron rod, marking a point on the north-south half section line of said Section 18 and the west line of a parcel of land now or formerly owned by D. Weaver;

thence S 00° 13' 32" W along said north-south half section line of said Section 18 and the west of line of said Weaver parcel a distance of 293.29 feet to the **POINT OF BEGINNING**.

Containing in all 4.429 acres of land, more or less, of which 0.268 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

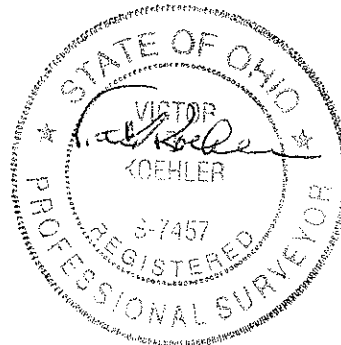
