**LEGAL DESCRIPTION OF A 23.766 ACRE PARCEL
FOR FRANKLIN TILE COMPANY**

Being a parcel of land situated in part of the Northeast Quarter of Section 6, T-3-S, R-14-E, in the City of Upper Sandusky, Crane Township, Wyandot County, Ohio, and further described as follows:

Commencing at a point marking the north quarter post of said Section 6, referenced by a found iron rod in a monument box situated N 00° 41' 30" W a distance of 0.71 feet and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing N 89° 44' 15" E along the north line of said Section 6 and the centerline of Spring Street a distance of 537.87 feet to a set MAG nail marking the west right-of-way of a parcel of land now or formerly owned by CSX Railroad, referenced by a set iron rod situated S 00° 27' 17" W a distance of 30.00 feet;

thence S 00° 27' 17" W along the west right-of-way line of said CSX Railroad a distance of 1998.16 feet to a set iron rod situated on a southerly corporation line of the City of Upper Sandusky, passing aforementioned set iron rod a distance of 30.00 feet;

thence S 89° 30' 50" W along a southerly corporation line of said City of Upper Sandusky a distance of 497.89 feet to a set iron rod marking the north-south half section line of said Section 6 and a westerly corporation line of said City of Upper Sandusky and the east line of a parcel of land now or formerly owned by F. & E. Leightey;

thence N 00° 41' 30" W along the north-south half section line of said Section 6 and a westerly corporation line of said City of Upper Sandusky and the east line of said F. & E. Leightey parcel a distance of 2000.00 feet to the **POINT OF BEGINNING**, passing a set iron rod for reference a distance of 1970.00 feet;

Containing in all 23.766 acres of land, more or less, of which 0.370 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

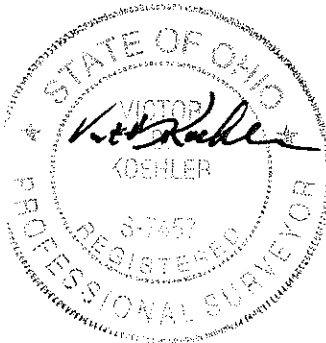
