**LEGAL DESCRIPTION OF A 0.254 ACRE PARCEL
FOR LAURA MAE PICKETT ESTATE**

Being a parcel of land situated in part of the Southeast and Southwest Quarters of Section 8, T-3-S, R-13-E, and being part of Lot #12 of the Original Plat of Burlington (now known as Marseilles) and unplatted Lands in the Village of Marseilles, Wyandot County, Ohio, and further described as follows:

Commencing at a set iron rod situated on the northerly line of Main Street and marking the southeasterly corner of Lot # 74 of Merriman's 2nd Addition to the Village of Marseilles and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 31° 00' 00" W along the easterly line of said Lot #74 a distance of 165.00 feet to a set iron rod on the southerly line of a 16.5 foot wide alley and marking the northeasterly corner of said Lot #74;

thence N 59° 00' 00" E along the southerly line of said alley a distance of 97.08 feet to a set iron rod marking a corner of Lot #12 of the Original Plat of Burlington (NKA: Marseilles);

thence S 00° 02' 11" E along Lot #12 a distance of 71.92 feet to a set iron rod;

thence S 31° 00' 00" E on a line a distance of 103.33 feet to a set iron rod on the northerly line of said Main Street;

thence S 59° 00' 00" W along the northerly line of said Main Street a distance of 60.08 feet to the **POINT OF BEGINNING**.

Containing in all 0.254 acre of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.


