LEGAL DESCRIPTION OF A 1.170 ACRE PARCEL

Being a parcel of land situated in part of the Southeast Quarter of Section 5, T-2-S, R-13-E, Salem Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 5;

thence on an assumed bearing of S 88° 25' 29" W along the centerline of Township Highway 42 a distance of 796.25 feet to a set MAG nail marking the southwest corner of a parcel of land now or formerly owned by Beth A. McDermott, referenced by a set iron rod situated N 01° 02' 01" W a distance of 20.00 feet;

thence N 01° 02' 01" W along said McDermott parcel a distance of 386.82 feet to a found iron pipe, passing the aforementioned set iron rod a distance of 20.00 feet;

thence S 88° 59' 01" W along said McDermott parcel a distance of 25.00 feet to a set iron rod;

thence N 31° 57' 09" W along said McDermott parcel a distance of 55.02 feet to a set iron rod;

thence N 40° 25' 45" W along said McDermott parcel a distance of 14.70 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 40° 25' 45" W along said McDermott parcel a distance of 221.95 feet to a set iron rod;

thence N 83° 15' 41" E along said McDermott parcel a distance of 344.11 feet to a found iron pipe;

thence S 88° 10' 55" E along said McDermott parcel a distance of 130.84 feet to a set iron rod;

thence S 01° 18' 35" E along said McDermott parcel a distance of 112.03 feet to a set iron rod;

Bearings are assumed and are for angular measurement only.


All set iron rods are 5/8" diameter with personalized plastic caps.
