**LEGAL DESCRIPTION OF A 3.000 ACRE PARCEL
FOR AARON PAHL**

Being a parcel of land situated in part of the Southeast Quarter of Section 31 T-1-S,
R-13-E, Crawford Township, Wyandot County, Ohio, and further described as follows:

Commencing at a set MAG nail marking the Southeast corner of said Section 31,
referenced by a set iron rod situated N 00° 21' 34" W a distance of 20.00 feet;

thence on an assumed bearing of S 89° 22' 28" W along the south line of said Section 31
and the centerline of County Highway 4 a distance of 646.00 feet to a set MAG nail and
being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a
set iron rod situated N 00° 37' 32" W a distance of 20.00 feet;

thence continuing S 89° 22' 28" W along the south line of said Section 31 and the
centerline of County Highway 4 a distance of 324.00 feet to a set MAG nail referenced
by a set iron rod situated N 00° 37' 32" W a distance of 20.00 feet;

thence N 00° 37' 32" W on a line a distance of 403.33 feet to a set iron rod, passing the
aforementioned set iron rod a distance of 20.00 feet

thence N 89° 22' 28" E on a line a distance of 324.00 feet to a set iron rod;

thence S 00° 37' 32" E on a line a distance of 403.33 feet to the **POINT OF
BEGINNING**, passing a set iron rod for reference a distance of 383.33 feet.

Containing in all 3.000 acres of land, more or less, of which 0.149 acre, more or less, is
currently contained within highway right-of-ways. The above described property being
subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
