**LEGAL DESCRIPTION OF A 3.868 ACRE PARCEL  
FOR KYLE ANDERSON**

Being a parcel of land situated in the part of the Southeast Quarter of Section 31, T-3-S, R-14-E, Pitt Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the center of said Section 31;

thence on an assumed bearing of N 89° 27' 04" E along the east-west half section line of said Section 31 a distance of 1322.32 feet to a set MAG nail and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a set iron rod situated S 00° 20' 51" E a distance of 30.00 feet;

thence N 89° 27' 04" E along said east-west half section line a distance of 250.00 feet to a set MAG nail, referenced by a set iron rod situated S 00° 19' 18" W a distance of 30.00 feet;

thence S 00° 19' 18" W on a line a distance of 685.00 feet to a set iron rod, passing the aforementioned set iron rod a distance of 30.00 feet;

thence S 89° 26' 00" W on a line a distance of 242.00 feet to a set iron rod marking the east line of a parcel of land now or formerly owned by S. Conway;

thence N 00° 20' 51" W along said Conway parcel a distance of 685.00 feet to the **POINT OF BEGINNING**, passing a set iron rod a distance of 655.00 feet.

Containing in all 3.868 acres of land, more or less, of which 0.172 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.


