**LEGAL DESCRIPTION OF A 3.000 ACRE PARCEL
FOR THE BARDON FAMILY**

Being a parcel of land situated in part of the Northwest Quarter of Section 6, T-3-S,
R-15-E, Antrim Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the west line of said Section 6 and the
intersection of the centerlines of County Highway 128 and Township Highway 55 and
being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of N 00° 19' 42" W along the west line of said Section 6
and the centerline of said County Highway 128 a distance of 475.21 feet to a set MAG
nail, referenced by a set iron rod situated S 89° 56' 06" E a distance of 20.00 feet;

thence S 89° 56' 06" E on a line a distance of 275.00 feet to a set iron rod, passing the
aforementioned set iron rod a distance of 20.00 feet;

thence S 00° 19' 42" E on a line a distance of 475.21 feet to a set MAG nail marking the
south line of the north half of the northwest quarter of said Section 6 and the centerline of
Township Highway 55, passing a set iron rod for reference a distance of 450.21 feet;

thence N 89° 56' 06" W along the south line of the north half of the northwest quarter of
said Section 6 and the centerline of Township Highway 55 a distance of 275.00 feet to
the **POINT OF BEGINNING**.

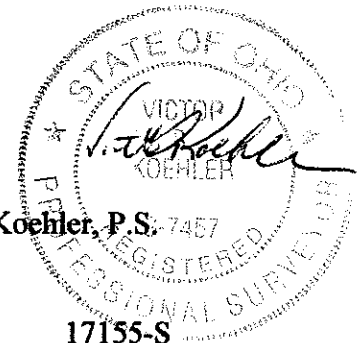
Containing in all 3.000 acres of land, more or less, of which 0.365 acre, more or less, is
