**LEGAL DESCRIPTION OF A 2.000 ACRE PARCEL
FOR AARON CLARK**

Being a parcel of land situated in part of the Southeast Quarter of Section 15, T-4-S, R-13-E, Marseilles Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the east quarter post of said Section 15 and the intersection of the centerlines of County Highway 77 and Township Highway 123 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 00° 00' 00" W along the east line of said Section 15 and the centerline of said Township Highway 123 a distance of 264.00 feet to a set MAG nail, referenced by a set iron rod situated N 89° 56' 20" W a distance of 20.00 feet;

thence N 89° 56' 20" W on a line a distance of 330.00 feet to a set iron rod, passing the aforementioned set iron rod a distance of 20.00 feet;

thence N 00° 00' 00" E on a line a distance of 264.00 feet to a set MAG nail marking the east-west half section line of said Section 15 and the centerline of County Highway 77, passing a set iron rod for reference a distance of 234.00 feet;

thence S 89° 56' 20" E along the east-west half section line of said Section 15 and the centerline of County Highway 77 a distance of 330.00 feet to the **POINT OF BEGINNING**.

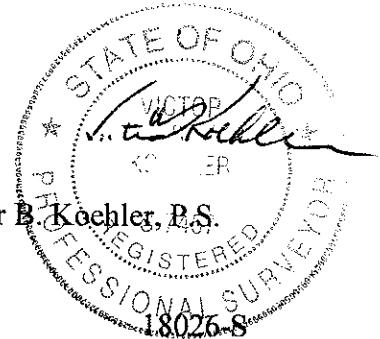

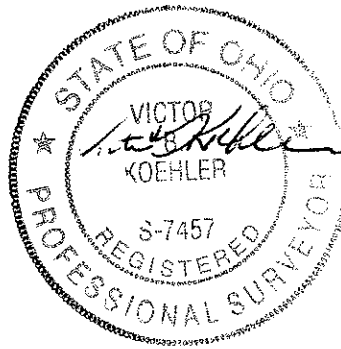
