Commencing at a found monument box marking the intersection of the east line of the west half of the southeast quarter of said Section 18 and the centerline of Saffell Street;

thence on an assumed bearing of N 02° 24' 21" W along the east line of the west half of the southeast quarter of said Section 18 a distance of 229.01 feet to a point on the north line of a 16 foot wide alley in Pennington's Addition to the Village of Sycamore and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated N 02° 24' 21" W a distance of 1.00 foot;

thence N 02° 24' 21" W along the east line of the west half of the southeast quarter of said Section 18 a distance of 70.00 feet to a set iron rod, passing the aforementioned found iron rod a distance of 1.00 foot;

thence N 87° 59' 41" E on a line a distance of 216.24 feet to a set iron rod;

thence S 02° 19' 58" E on a line a distance of 70.00 feet to a set iron rod marking the north line of said 16 foot wide alley in Pennington's Addition to the Village of Sycamore;

thence S 87° 59' 41" W along the north line of said 16 foot wide alley in Pennington's Addition to the Village of Sycamore a distance of 216.15 feet to the **POINT OF BEGINNING**.

thence on an assumed bearing of N 02° 24' 21" W along the east line of the west half of the southeast quarter of said Section 18 a distance of 229.01 feet to a point on the north line of a 16 foot wide alley in Pennington's Addition to the Village of Sycamore, referenced by a found iron rod situated N 02° 24' 21" W a distance of 1.00 foot;

thence N 87° 59' 41" E along the north line of said 16 foot wide alley in Pennington's Addition to the Village of Sycamore a distance of 232.15 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel, passing a set iron rod a distance of 216.15 feet;
