SITUATED IN THE STATE OF OHIO, COUNTY OF WYANDOT, CITY OF UPPER SANDUSKY, AND BEING PART OF THE LANDS OF UPPER SANDUSKY OF THE NORTHWEST QUARTER OF SECTION 5, TOWNSHIP 3 SOUTH, RANGE 14 EAST, CRANE TOWNSHIP, AND BEING 2.681 ACRES TOTAL, 0.368 ACRES CONVEYED TO M.J. DIVERSIFIED GP, LLC OF RECORD IN OFFICIAL RECORD 249, PAGE 1367 AND ALSO BEING 2.313 ACRES CONVEYED TO M.J. DIVERSIFIED GP, LLC OF RECORD IN OFFICIAL RECORD 228, PAGE 1656, RECORDS REFER TO THE COUNTY RECORDER'S OFFICE, WYANDOT COUNTY, OHIO AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS;
