**LEGAL DESCRIPTION OF A 5.595 ACRE PARCEL**  
**FOR JIMMY OWEN**

Being a parcel of land situated in part of the Southeast Quarter of Section 2, T-4-S, R-12-E, Marseilles Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 2 and the centerline of Township Highway 71 and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 88° 01' 57" W along the south line of said Section 2 a distance of 40.01 feet to a set MAG nail, referenced by a set iron rod situated N 00° 54' 43" W a distance of 30.01 feet;

thence N 00° 54' 43" W on a line a distance of 465.00 feet to a set iron rod, passing the aforementioned set iron rod a distance of 30.01 feet;

thence N 29° 05' 38" W on a line a distance of 585.95 feet to a set iron rod;

thence N 52° 23' 22" W on a line a distance of 459.73 feet to a set iron rod;

thence S 88° 37' 08" E on a line a distance of 676.95 feet to a set iron rod marking the east line of said Section 2;

thence S 00° 54' 43" E along the east line of said Section 2 a distance of 1240.00 feet to the **POINT OF BEGINNING**.

Containing in all 5.595 acres of land, more or less, of which 0.028 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
