Commencing at a set iron rod marking the northwest corner of Lot #9 of said Beckwith's Subdivision and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence on an assumed bearing of S 00° 21' 30" E along the west line of said Lot #9 and the east line of said vacated alley a distance of 79.00 feet to a set iron rod marking the southwest corner of said Lot #9;

thence S 89° 38' 30" W on a line a distance of 12.00 feet to a set iron rod marking the west line of said vacated alley;

thence N 00° 21' 30" W along the west line of said vacated alley a distance of 81.37 feet to a set iron rod;

thence S 79° 10' 50" E on a line a distance of 12.23 feet to the **POINT OF BEGINNING**.

Containing in all 0.022 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.

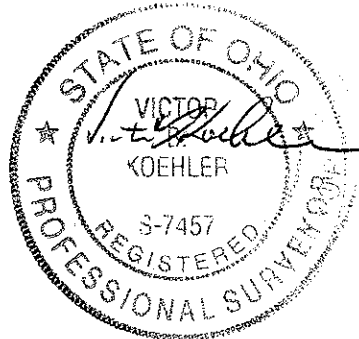

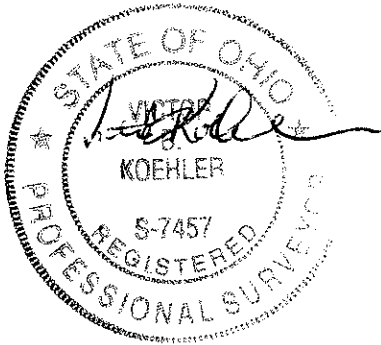

Commencing at a set iron rod marking the west right-of-way of Beckwith Drive and the northeast corner of Lot #9 of Beckwith's Subdivision and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 77° 28' 23" W along the north line of said Lot #9 of Beckwith's Subdivision a distance of 134.14 feet to a set iron rod marking the northwest corner of said Lot #9;

thence S 79° 10' 50" E on a line a distance of 134.23 feet to a set iron rod marking the west right-of-way line of said Beckwith Drive;

thence along the west right-of-way of said Beckwith Drive on a curve to the left a distance of 4.00 feet having a chord of 4.00 feet and a chord bearing of S 12° 58' 19" W to the **POINT OF BEGINNING**.
