**LEGAL DESCRIPTION OF A 30.000 ACRE PARCEL

Being a parcel of land situated in part of the Southwest Quarter of Section 28, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found post marking the center of said Section 28, referenced by a found iron rod situated S 89° 11' 00" W a distance of 1.00 foot;

thence on an assumed bearing of S 89° 11' 00" W along the east-west half section line of said Section 28 a distance of 140.68 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel, passing the aforementioned found iron rod a distance of 1.00 foot;

thence S 01° 32' 27" E on a line a distance of 137.87 feet to a set iron rod;

thence N 89° 55' 03" W on a line a distance of 224.65 feet to a set iron rod;

thence S 00° 48' 29" W on a line a distance of 1196.04 feet to a set iron rod;

thence S 88° 23' 20" W on a line a distance of 942.00 feet to a set iron rod marking the east line of the west half of the southwest quarter of said Section 28;

thence N 00° 21' 18" W along the east line of the west half of the southwest quarter of said Section 28 a distance of 1343.00 feet to a found iron rod marking the east-west half section line of said Section 28;

thence N 89° 11' 00" E along the east-west half section line of said Section 28 a distance of 1187.88 feet to the **POINT OF BEGINNING**, passing a found iron rod a distance of 479.71 feet.

Containing in all 30.000 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
