Being a parcel of land situated in part of Lots #53, #54, #55 and #56 in Buell's Addition, in the Village of Carey, Wyandot County, Ohio, and further described as follows:

Commencing at a found iron rod marking the southeast corner of said Lot #52 and the northeast corner of said Lot # 57 and the northeast corner of a parcel of land now or formerly owned by E. & N. Hotelling, L.E. Etal.;

thence on an assumed bearing of S 81° 30' 56" W along the north line of said E. & N. Hotelling, L. E. Etal. parcel a distance of 69.94 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence continuing S 81° 30' 56" W along the north line of said E. & N. Hotelling, L. E. Etal. parcel a distance of 28.35 feet to a found iron rod;

thence N 05° 07' 21" W on a line a distance of 185.82 feet to a point marking the south right-of-way line of Clay Street, referenced by a found iron rod situated N 05° 07' 21" W a distance of 1.78 feet;

thence S 81° 23' 20" E along the south right-of-way line of said Clay Street a distance of 31.28 feet to a set iron rod;

thence S 04° 26' 50" E on a line a distance of 176.74 feet to the **POINT OF BEGINNING**.

Containing in all 0.122 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

Commencing at a found iron rod marking the southeast corner of said Lot #52 and the northeast corner of said Lot # 57 and the northeast corner of a parcel of land now or formerly owned by E. & N. Hotelling, L. E. Etal.;

thence on an assumed bearing of S 81° 30' 56" W along the north line of said E. & N. Hotelling, L. E. Etal. parcel a distance of 38.54 feet to a set iron rod and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence continuing S 81° 30' 56" W along the north line of said E. & N. Hotelling, L. E. Etal. parcel a distance of 31.40 feet to a set iron rod;

thence N 04° 26' 50" W on a line a distance of 176.74 feet to a set iron rod marking the south right-of-way line of Clay Street;

thence S 81° 23' 20" E along the south right-of-way line of said Clay Street a distance of 32.90 feet to a set iron rod;

thence S 04° 11' 48" E on a line a distance of 167.10 feet to the **POINT OF BEGINNING**.

Containing in all 0.125 acres of land, more or less. The above described property being subject to all legal highways and easements of record.

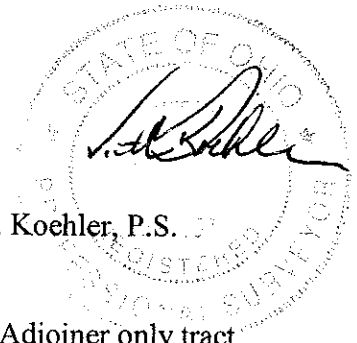

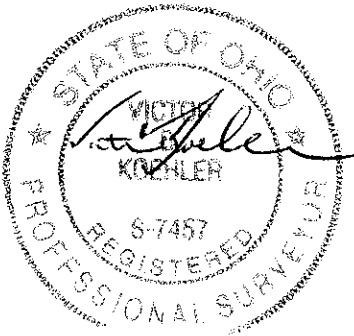
