Survey Description

Situated in the Township of Mifflin, County of Wyandot, State of Ohio and being a part of the Northeast Quarter of the Southeast Quarter of Section Thirty-one (31), Township Three (3) South, Range Thirteen (13) East, and being more particularly bounded and described as follows:

Commencing at a stone and monument box found at the Northeast Corner of the Southeast Quarter Section Thirty-one (31) and the intersecting centerlines of County Road #96 and State Route 294, thence South $00^{\circ} - 00' - 00''$ West along and with the East Line of the Southeast Quarter Section 31 and the centerline of County Road 96 a distance of 951.54 feet to a railroad spike found, the Place of Beginning;

Thence continuing South $00^{\circ} - 00' - 00''$ West along and with the aforesaid East Line of the Southeast Quarter Section 31 and the centerline of County Road 96 a distance of 375.00 feet to a railroad spike set;

Thence South $89^{\circ} - 34' - 20''$ West and parallel with the South Line of the Southeast Quarter Section 31, passing over an iron pin set at 30.00 feet, a distance of 800.00 feet to an iron pin set;

Thence North $00^{\circ} - 00' - 00''$ East and parallel with the East Line of the Southeast Quarter Section 31 a distance of 88.00 feet to an iron pipe set;

Thence North $62^{\circ}25'18''$ East a distance of 628.66 feet to an iron pipe found in an existing property corner;

Thence North $89^{\circ}29'25''$ East a distance of 41.89 feet to an iron pipe found;

Thence South $70^{\circ}21'50''$ East a distance of 99.73 feet to an iron pipe found;


Thence North $71^{\circ}50'30''$ East, passing over an iron pipe found at 83.42 feet, a distance of 112.53 feet to the Place of Beginning.

Containing 4.971 acres more or less and subject to legal highways, easements and restrictions of record. *Being 0.171 Acres in Right-of-Way.*

Bearing reference was assumed as shown on the accompanying survey plat dated October 10th, 1986 and prepared by Jacques M. Glaze.




