**LEGAL DESCRIPTION OF A 5.000 ACRE PARCEL
FOR M. BASH TRUSTEE**

Being a parcel of land situated in part of the Southeast Quarter of Section 32, T-2-S, R-12-E, Richland Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found nail marking the intersection of the south line of said Section 32 and the centerline of County Highway 78, referenced by a found iron rod situated S 89° 21' 23" E a distance of 41.79 feet;

thence on an assumed bearing of N 37° 11' 59" W along the centerline of said County Highway 78 a distance of 118.12 feet to a found railroad spike marking a corner of a parcel of land now or formerly owned by J. Searfoss, Etal. and being the **POINT OF BEGINNING** of the hereinafter described parcel, referenced by a found iron rod situated N 25° 50' 52" E a distance of 36.11 feet;

thence N 40° 11' 00" W along the centerline of said County Highway 78 a distance of 520.00 feet to a set MAG nail, referenced by a set iron rod situated N 49° 49' 00" E a distance of 33.00 feet;

thence N 49° 49' 00" E on a line a distance of 487.77 feet to a set iron rod, passing the aforementioned set iron rod a distance of 33.00 feet;

thence S 64° 09' 08" E on a line a distance of 277.00 feet to a set iron rod marking the northwesterly line of said J. Searfoss, Etal. parcel;

thence S 25° 50' 52" W along said J. Searfoss, Etal. parcel a distance of 656.95 feet to the **POINT OF BEGINNING** passing a found iron rod a distance of 620.84 feet.

Containing in all 5.000 acres of land, more or less, of which 0.388 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
