**LEGAL DESCRIPTION OF A 2.065 ACRE PARCEL
FOR MCCLEARY/CROSS**

Being a parcel of land situated in part of the Southeast Quarter of Section 33, T-3-S, R-13-E, Mifflin Township, Wyandot County, Ohio, and further described as follows:

Commencing at a found stone marking the southeast corner of said Section 33 and the centerline of Township Highway 103;

thence on an assumed bearing of N 00° 32' 24" W along the east line of said Section 33 and the centerline of said Township Highway 103 a distance of 1329.14 feet to a found MAG nail marking a corner of a parcel of land now or formerly owned by J. & B. Miller and being the **POINT OF BEGINNING** of the hereinafter described parcel;

thence N 89° 06' 11" W along said J & B. Miller parcel a distance of 305.00 feet to a set iron rod, passing a found iron rod a distance of 25.01 feet;

thence N 00° 32' 24" W on a line a distance of 295.00 feet to a set iron rod;

thence S 89° 06' 11" E on a line a distance of 305.00 feet to a set MAG nail marking the east line of said Section 33 and the centerline of said Township Highway 103, passing a set iron rod a distance of 279.99 feet;

thence S 00° 32' 24" E along the east line of said Section 33 and the centerline of said Township Highway 103 a distance of 295.00 feet to the **POINT OF BEGINNING**.

Containing in all 2.065 acres of land, more or less, of which 0.169 acre, more or less, is currently contained within highway right-of-ways. The above described property being subject to all legal highways and easements of record.

Bearings are assumed and are for angular measurement only.

All set iron rods are 5/8" diameter with personalized plastic caps.
